The Waukesha Farmers' Market runs from the first Saturday in May to the last Saturday in October, regardless of weather, from 8 am - 12 pm. Please submit your application via email (mailto:marketadmin@waukeshadba.com) or mail (235 W. Broadway St., Waukesha, WI 53186) as soon as possible to secure your preferred dates. The Waukesha Farmers' Market Coordinator will provide a shared schedule with all musicians no later than April 1st. Each Wednesday, the Market Coordinator will confirm time slots with the musicians scheduled. If you are unable to attend a scheduled date, we ask that you contact us as soon as possible, but no later than 72 hours before your scheduled time. If you need to cancel due to an emergency within 24 hours of your performance, we ask that you contact the Market Coordinator (marketadmin@waukeshadba.com) and the Market Manager (262-336-6716).

Additionally, all Musicians agree to:

- Arrive by 7:45 am for the 8:00 am shift. Arrive by 9:45 am for the 10:00 am shift.
- Play music that is family-friendly.
- Be respectful with volume. Please comply with any volume requests made by the Market Management Team.
- Comply with cancellation notice. Frequent cancellation may lead to removal from the remainder of the schedule.
- To ensure a safe environment for all, musicians should not bring pets or children under 6 to the Market without proper supervision. They are not allowed in the tent.

The Waukesha Farmers Market will provide/allow the following:

- Inverter Generator, if needed.
- 10x10 tent
- Reserved parking spots near the tent, which is located near the corner of Madison and St. Paul.
- Allow musicians to sell/market their merchandise.
- Tip jar is allowed. Musicians/Groups will be \$50 per shift. If working a full 4 hour shift, Musicians/Groups will receive \$100.
